**Magellan Aerospace Secures Contracts for Engine Front Frames and Shafts**

**Toronto, Ontario – 29 April 2019** -- Magellan Aerospace Corporation (“Magellan”) announced agreements today with an undisclosed customer for the supply of complex fabricated engine front frames for a commercial platform, to be manufactured at Magellan’s facility in Winnipeg, Manitoba, Canada, and critical rotating engine shafts for a dual use platform, to be manufactured at Magellan’s facility in Haverhill, Massachusetts, USA. These contracts are valued at approximately CDN \$45 million and will be delivered starting in 2019 through 2022.

Magellan has made significant investments in manufacturing technology and personnel at its facilities enhancing our ability to compete in a global market. In securing these agreements, Magellan has demonstrated the ability to meet the competitive demands of cost, quality and performance expected by the aerospace markets.

The confidence that OEM customers have placed in Magellan is significant and demonstrates our capability to offer our customers a technologically advanced and reliable solution.”
